Please note: Fees are from 1st July 2011 to June 30th 2012 only. AWA & MAAA Fees after December 31st are at half rate to new members or ex-members who are re-joining after a break of over 12 months.

Senior fees from January are indicated above. Joining fee still applies.

All Memberships terminate on June 30th every year. There is no concession.

If in doubt, please contact the Treasurer for confirmation of fees before payment.

WAMASC family membership provides for 2 Parents (or Partners or Guardians) and 2 Junior's of the same family. There is no family discount for AWA & MAAA, these fees apply for each person. Membership status cannot be varied throughout the year. A junior in the 2011/2012 membership year is anyone born on or after July 1st 1993. Family Fee payable is calculated as follows: [Adults X (a+e)] + [Juniors X (b+c)] + (f) if new membership.

Members who are renewing within 12 months pay the full yearly renewal fee regardless of when in the year they renew. All Memberships terminate on June 30th every year.

A new membership application may be made not more than three weeks before the commencement of the new membership year. A new member may then have a maximum of two visits which include flying familiarization and or training during that three week period. Payment of fees prior to this date may be made, but would be considered an application for membership in the year of membership expiring 30th June and not for the new year commencing 1st July.
